HOFFMAN TO PAY SPECIAL ATTENTION TO THE AREA OF SCOTT RIDGE NEAR APT J. LT. HOFFMAN STATED HE HAD RECEIVED SEVERAL COMPLAINT FROM CONCERNED CITIZENS ABOUT CONSTANT STREET LEVEL DRUG DEALING THAT OCCURES IN THIS COMPLEX ON A DAILY BASIS. LT. HOFFMAN ADVISED ME TO PAY SPECIAL ATTENTION TO QUALITY OF LIFE CRIMES IN THIS AREA SUCH AS DRUG DEALING, TRESSPASSING AND LARGE GROUPS OF PEOPLE CONGERGATING IN THIS AREA CAUSING DISURBANCES.

AT THIS TIME A SMALL CROWD OF ABOUT 10-15 B/M'S BEGAN TO GATHER AROUND MYSELF AND OFC. MATURO. I OBSERVED MORE YOUNG B/M'S BEGIN TO WALK TOWARDS US. MR MORRISON CONTINUED TO INCITE THE CROWD BY SAYING"THESE COPS ALWAYS FUCK WITH US,I AM SICK OF THIS SHIT"I OBSERVED THIS CROWN BEGIN TO VOICE THERE HOSTILETYS TOWARDS AS BY SAYING"FUCK THESE MOTHERFUCKERS" I ATTEMPTED TO PLACE MY ARM ON MR MORRISON AS HE WAS CONTINUING TO INCITE THE CROWD.

BACK INTO HIS APARTMENT AND SAID"COME ON IN AND GET ME, I WILL FUCK YOU UP" I THEN TOLD MR AVILA'S MOTHER HER SON WAS GOING TO BE ARRESTED.
