DEFENDANT TONY DELUCIA'S MEMORANDUM IN AID OF SENTENCING

On August 15, 2009 defendant TONY DELUCIA pleaded guilty to Conspiracy to Possess With Intent to Distribute Cocaine, in violation of 21 U.S.C. §§ 841(a)(1), (b)(1)(c) and 846. The defendant has reviewed her Presentence Report ("PSR") prepared by Senior United States Probation Officer Ray Lopez. The defendant accepts responsibility for her criminal conduct, and acknowledges that her sentencing guidelines range is between 18 to 24 months' imprisonment. The defendant understands that her guidelines range has been determined based on her attributed drug quantity and her criminal history.

Ms. Delucia faces the possibility of incarceration because she purchased cocaine on a number of occasions both for personal use and to distribute to friends and family

members. Although the defendant did not engage in this activity for profit, and did not use drugs frequently or consistently, the defendant has had prior involvement with the criminal justice system. The defendant had previously been given an opportunity, via probation, to straighten out her life and make better choices, but as evidenced by this arrest, it appears that she has not taken advantage of that opportunity. Arguably, prior sentences of probation were not severe enough to deter Ms. Delucia from re-engaging in criminal conduct. While arguments for a short period of incarceration are valid, undersigned counsel respectfully submits that a sentence of probation with a period of home confinement is sufficient to meet the goals of sentencing for this particular individual.

THE 18 U.S.C. § 3553(a) FACTORS.

The Court is well aware of the sentencing factors that must be considered in determining an appropriate sentence. The defendant respectfully submits that the defendant's guidelines' range would not result in a sentence that complies with the parsimony clause in 18 U.S.C. § 3553(a). The relevant § 3553(a) sentencing factors² mitigate in favor of a sentence of probation.

The nature and circumstances of the offense.

Ms. Delucia's role in this offense, while not minimal, was relatively minor. As indicated in the PSR, Ms. Delucia purchased cocaine from Tito Rodriguez, the lead codefendant in this case, on several occasions between November, 2008 and May, 2009. The defendant initially had difficulty accepting responsibility for her role as a coconspirator in a drug distribution venture for a number of reasons. The defendant purchased narcotics mostly for personal use, and distributed to and used with friends and family members. Approximately a year after her arrest, the government made the meaningful point to the defendant that "sharing" is how drugs get distributed among the community. Large-scale dealers dispense drug to people who in turn share or sell to others.

Part of Ms. Delucia's initial inability to fully appreciate the seriousness of her conduct comes from the fact that Ms. Delucia grew up in an environment where drug use was widespread and accepted. Despite this, the defendant had always fulfilled her duties as a wife, mother, and business owner. She was able to function while using drugs, so, like many addicts, thought that as long as her drug use did not interfere with her responsibilities, she did not have a problem. Because the defendant regarded herself as a

"recreational user" she did not accept that her drug use had a negative impact on every aspect of her life. As discussed below, the defendant has begun to realize that she must make difficult and meaningful changes in her lifestyle. Ms. Delucia accepts responsibility for her conduct, has made some significant life changes over the past year, and plans to continue to create a better life for herself if given the opportunity.

The history and characteristics of the defendant.

As stated above, Ms. Delucia grew up in an environment where drug use was common. Ms. Delucia married Sal Delucia in 1987. The defendant met Mr. Delucia when she was fifteen years old, and he was the defendant's only serious boyfriend. They began dating, and shortly thereafter, moved in together next door to Ms. Delucia's parents' house. Although their marriage was not perfect, Mr. Delucia had a steady job in construction and he was able to provide for Ms. Delucia and their children.

In 1991, Mr. Delucia sustained a serious back injury while at work. Mr. Delucia underwent back surgery, and he began taking pain medication. Mr. Delucia had used illicit substances in the past, and his use of prescription medication quickly turned to addiction. For the following eleven years, Ms. Delucia attempted to help her husband overcome his addiction to pain medication, and urged him to seek treatment when he began to abuse heroin, cocaine and crack cocaine. The defendant was able to convince

Mr. Delucia to participate in inpatient treatment, and secured for him a bed at Silver Hill Hospital in New Canaan, CT. Although Mr. Delucia entered treatment, his commitment to sobriety was short-lived. Mr. Delucia lost his job, was unable to maintain steady employment, and began to steal from his family, fail to show up at family functions and cheat on the defendant. Throughout her ordeal, Ms. Delucia continued to work long hours, help her parents with household chores, raise her children, and rarely had any time for herself.

In 1997, Ms. Delucia told her husband to leave the house. Although Ms. Delucia would allow him to return home, whenever he returned he stole from the family, engaged in other criminal acts, and ultimately went to jail. Ms. Delucia's daughters did not understand why their father was unavailable and often blamed Ms. Delucia for his absence. Friends recount Ms. Delucia's efforts to play the role of both mother and father without any support from her husband's side of the family. Ultimately, despite Ms. Delucia's efforts to preserve the family unit, Mr. Delucia abandoned the family.

In August of 1997, the defendant and a long-time friend, Trudy DeMauro, bought a storefront at 1514 Quinnipiac Avenue in New Haven, CT, and completely renovated the property. They opened a deli that they named T & T Deli, and Ms. DeMauro, who was also in the process of a divorce, lived on the second floor of the building with her

youngest child. The defendant threw herself into her work. For the past twelve years, the defendant has cooked, cleaned, and worked at the deli almost every day. To date, the defendant is still responsible for almost every aspect of the business. In addition to cooking and cleaning and working at the cash register, she maintains the grounds and the building, and monitors the inventory.

The defendant has continued to care for her parents throughout the years. Ms. Delucia's parents are in their late seventies, and her father has recently been hospitalized. The defendant still lives next door to her parents, and she is their primary caregiver. Although Ms. Delucia has three brothers and a sister, Ms. Delucia assumes most of her parents' housekeeping responsibilities, and runs errands for them on a weekly basis.

The defendant's three daughters continue to rely upon her for financial support and child care. Ms. Delucia's 19 year old daughter, Nicole, lives with the defendant. Nicole Delucia is a single mother, and Ms. Delucia allows her daughter to live with her in the hopes that Nicole will complete her education and find stable employment. Ms. Delucia cares for her grandsons on a regular basis. She makes sure they are well fed and that they get to school on time every day. The defendant is extremely attached to her grandsons and always makes herself available whenever she is needed for childcare.

As evidenced by the attached letters from friends and family, Ms. Delucia is a loyal and generous friend. The defendant makes many charitable contributions to her local community. Ms. Delucia assists the elderly in her neighborhood by providing them with home-cooked meals free of charge, and she frequently donates trays of food to local fund-raising events. Friends and family members rely on her for emotional and financial support. Several of her friends have recounted the ways in which Ms. Delucia has sacrificed for others (see attached). It is apparent that some individuals take advantage of the fact that Ms. Delucia never says no. It is also apparent that Ms. Delucia's tendency to put everyone else first has taken its toll on the defendant.

Ms. Delucia's sense of responsibility for her friends and family has been a source of stress for the defendant. Rather than reach out for help or say no, Ms. Delucia hides her anxiety and internalizes her unhappiness. The defendant's way of relieving stress has always been to drink or use drugs; for her, it was a means of escape. From Ms. Delucia's perspective, as long as her drug use was "under control" and she was able to continue to work and provide for her family, she did not have a problem. Obviously, the defendant does have a problem, and at age 52, she is attempting to make amends for her criminal conduct and the negative effects it has had on her life and her family.

The need to promote respect for the law, provide just punishment for the offense and to provide the defendant with needed treatment.

The defendant's role in this offense and her personal characteristics mitigate in favor of probation. Any restriction on the defendant's liberty would be an increased sanction that would have a deterrent effect. A sentence of home confinement would enable the defendant to get mental health counseling and to continue substance abuse counseling in the community. The defendant has actively engaged in treatment at the Chemical Abuse Services Agency in New Haven, CT (see attached). Undersigned counsel spoke with the defendant's treatment provider, Robin Rigney, and she has stated that Ms. Delucia actually *wants* to attend treatment and has made a genuine effort to incorporate coping techniques into her daily life. Significant mental health and substance abuse counseling will assist the defendant in finding other outlets for everyday stresses and maintaining abstinence even while she is surrounded by those who still use drugs.

The defendant will abide by whatever conditions the Court imposes if she is given the opportunity to serve her sentence in the community. Ms. Delucia has demonstrated her ability to abide by the Court's orders. Upon her arrest, the defendant was placed on electronic monitoring. The defendant complied with her curfew and other conditions of pretrial release³ and the bracelet was removed after approximately two months. The defendant was able to abide by the conditions of her release while working, supporting her family and engaging in treatment, and she will do so again if given the opportunity to remain in the community.

The need to protect the public and deter the defendant from committing further crimes.

Ms. Delucia's substance abuse is symptomatic of her inability to deal with the chaos in her life. The defendant has been arrested several times in the past, and was sentenced to probation or fined in almost every instance. Under almost all sentencing theories, a defendant's past criminal history is considered in order to ensure that incrementally increased sanctions are imposed for those who do not seem to learn their lesson; this principle is one of the purported goals of the Sentencing Guidelines. It appears as if probation has not been a sufficient sanction to prompt the defendant to change her lifestyle.

Undersigned counsel respectfully submits that Ms. Delucia's criminal history is overstated, and that she accumulated most of her criminal history points during an

extremely turbulent period in her life. Most of the defendant's criminal history points are the result of disputes with her business partner and best friend, Trudy DeMauro. Ms. Delucia and Ms. DeMauro have a history together that includes opening and running a business, presence in each other's life for every milestone, and, unfortunately, drug abuse and even more troubling, Ms. DeMauro's indiscretions with Ms. Delucia's ex-husband. It was the discovery of these indiscretions that triggered a series of altercations between Ms. Delucia and Ms. DeMauro that led to Ms. Delucia's arrest on several occasions.

Undersigned counsel has met with Ms. DeMauro and Ms. DeMauro has confirmed that the majority of Ms. Delucia's prior criminal conduct resulted from personal arguments. Ms. DeMauro has indicated that she deeply regrets her actions and the ensuing disputes. Ms. DeMauro has recounted several instances where, despite Ms. DeMauro's betrayal, Ms. Delucia has supported her through surgery, loss and other hardships. It is unfathomable to undersigned counsel how Ms. Delucia and Ms. DeMauro have remained business partners and friends. Importantly, both parties appear to have matured, forgiven each other for their past conflicts, and their relationship seems to be incident-free.

At the age of 52, the defendant has started to reflect on her life decisions and to move in a positive direction. The defendant seems to have finally taken inventory of her

life. She realizes that her daughters have all been impacted by her life circumstances and poor choices, and she is attempting to help them to make better decisions. The defendant wants to set a positive example for her grandchildren. Ms. Delucia has learned through counseling that she needs to address issues underlying her substance abuse and abstain from use altogether. The defendant is making changes in her work and personal environment to ensure that she recreates for herself a healthier—and better—life.

Community-based treatment is appropriate given the defendant's personal circumstances.

Approximately one year ago, Ms. Delucia resolved to take affirmative steps to ensure that the rampant drug use in her area would not overflow into her life again. Ms. Delucia had been renting the apartment above her deli for several years. In November, 2009, upon confirming her suspicions that the tenants were selling drugs from the apartment, Ms. Delucia asked them to leave.

Since their departure, Ms. Delucia has completely remodeled the space and is in the process of turning the apartment into a sober house. With the help of friends, the defendant has cleaned out the premises and transformed it from a two bedroom apartment to an open-style suite that can house up to seven residents. Ms. Delucia has met with

several owners of halfway houses in the New Haven area, and has done a significant amount of research regarding how to run a sober house as a business.

While working on this project and awaiting sentencing, Ms. Delucia has continued to work full-time at the deli, and care for her children, grandchildren and parents. Allowing the defendant to remain in the community will enable her to continue to work and care for her loved ones, and receive mental health and substance abuse counseling. The defendant has begun to take responsibility for herself, and is more emotionally stable. Importantly, she is making tangible life changes that show her commitment to making better choices for herself, her family and her future. This personal progress benefits the community as well.

CONCLUSION

Undersigned counsel cannot point to one aspect of Ms. Delucia's character, history or personal circumstances and argue that it is so significant that that thing alone warrants another chance. A person is a sum of their parts; all of the individual characteristics of the defendant, considered together, are compelling and support a sentence of probation. A sentence of probation with a period of home confinement, and with conditions specifically tailored to this particular defendant, would serve as an adequate deterrent, assist in the defendant's rehabilitation, and be in the interests of justice. A sentence

below the guidelines range that takes into account all of the above-mentioned mitigating circumstances and recognizes the genuine efforts the defendant has made thus far to make amends, with an order that she participate in mental health counseling and in intensive outpatient drug treatment program, would be in the interests of justice.

The only thing that I can do is write this letter so you may become aware and familiar of the many great attributes my friend possesses so that when you are reviewing her file and deciding her fate, you can recall the person that I know and love.

I will try my best to describe Toni. She has an amazing ability to connect with people. I recall meeting her for the first time as if it were yesterday. She has a refreshing candidness that reveals itself early on in her relationships. She comes across with no hidden or private thoughts or agendas. She shows you her sole and her heart almost instantaneously. Her warmth and kindness are always on display.

I met her when I stopped to buy a steak and cheese sandwich at her deli. There were many different types of people having lunch there at the time. She knew all of them on a first name basis. They all enjoyed the light-hearted banter that just seemed to bring the small roadside eatery to life.

As time went on, I began to ride my motorcycle with Toni. She has an encyclopedic knowledge of Harley Davidson motorcycles and I am trying to learn as much as I can. We ride on most days when the weather permits. While spending this time with her, I've had a ringside seat or at least a small window into her life.

Judge, I am telling you that she is simply amazing. She is all things to many people. Her house is next door to her parents' house. Her parents ask a lot of her and she never says

no to them. During any given week, she may be asked to clean for them, run errands for them or help them financially. To my knowledge, she has never refused them. Its simply not in her vocabulary to say no.

She also has three daughters that she continues to care for and basically mother their respective needs. The youngest, Nicole, who is about eighteen now needs her mother on a daily basis. Nicole has some type of undiagnosed issue where without mom, she may slip into a very bad depression or worse. Every time I visit, Nicole needs mom to intervene with a problem that she cannot figure out for herself. The last time I can recall specifically, Nicole needed to remedy a car insurance misunderstanding. Toni spent several hours on the phone and fixed the problem. I know that without her mother there to fix things, Nicole would not be able to drive today.

There are two other children, Jennifer and Chrissy. Jennifer resides with mom. Chrissy is recently married but the two of them rely on mom very heavily. Last week, Jennifer needed mom to help her with filling out her income taxes. Toni helped her complete the forms and has always been there to show Jennifer right from wrong. Chrissy, even with her new husband, also seems to be asking mom for advice quite frequently and I cannot imagine how these girls would survive without mom to guide them.

As you know, she got into some trouble and maybe facing some consequences that would have a ripple effect that would bring a family to its knees. Toni is a mom to three girls that even in their older years, rely on mom to be there to help fix things in this world for each of them. Toni is also a daughter, a great daughter, to her parents that would also be lost without her.

Since the incident, I see Toni on a regular basis. She has done everything she possibly can do to make things right for herself and her family. Her remorse is plain to see. She has been on the strait and narrow and I intend on keeping it that way.

So I implore you, to find it in your heart to allow us to keep Toni from the grim possibilities that are facing her. She means a lot to many and she is a friend to all.
